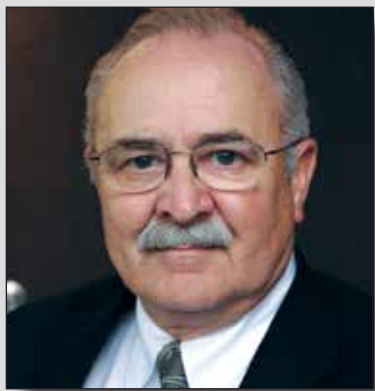

## Shalimar Gonzales is shaking things up at the West Seattle YMCA

Not only did the West Seattle YMCA recently receive a facelift—but the location also recruited a new face to serve at its helm.

Shalimar Gonzales took over as executive director just a couple of weeks ago and is eager to put her stamp on the place.

Gonzales spent the past three years as executive director at the Meredith Matthews East Madison YMCA, where her main mission was “making sure the Y represents the community we’re trying to serve and that we create safe spaces for everyone.”

Now she wants to do the same thing in a different neighborhood.

As Gonzales walks through the newly improved West Seattle YMCA, she is visibly brimming with excitement. A new family wing is one of her favorite parts, and she reports recently challenging a teenager to shoot some hoops in the “Tween Zone.”

A number of storage closets and seldom-used rooms have been converted to more functional spaces, she added.

The main fitness area has been completely redone and light now pours into the cardio area thanks to a row of win-

dows. There’s also a new gender-neutral and family changing area.

“I get to reap the benefits of a new space,” Gonzales said.

She is still unpacking her belongings and setting up her office.

While the set-up may be different, the Y is familiar territory to Gonzales.

Originally from San Francisco, she moved to Seattle in high school and started working for the YMCA not too long after. While on the way to receiving her degree in liberal studies from Seattle University, she got a job at the downtown Y location her sophomore year, about 14 years ago.

“I totally stumbled into the Y,” she said.

A friend suggested that Gonzales apply—and she took to it like a duck to water. It wasn’t long before she was head of a unique new program for young adults, creating an all-ages music venue out of a few empty rooms.

“We ended up having really awesome touring bands coming through the downtown Y,” Gonzales recalled. “We’d have 250 to 300 kids there a night.”

She also ran a youth gallery and art program, which gave young artists an opportunity to sell their work and gain exposure for their talent.

Gonzales went on to join the YMCA’s membership team—and then moved to Los Angeles to become associate director of membership for the nonprofit. Eventually, she started working with the diversity program.

“We were creating pathways for people of color to get into leadership roles,” Gonzales said. “Our intention was to give people the training and opportunities they needed so when jobs became avail-

## Syttende Mai parade attracts thousands to Ballard, inspires smalltown feel

This year thousands of spectators flocked to Ballard for the annual 17th of May Syttende Mai parade, expressing jubilation and pride for Norwegian heritage.

Among the 81 groups in the parade, people brandished bunaders and danced to Scandinavian songs of old. One group even made it out from Concordia College in Moorhead, Minn., and others from all over the region.

Syttende Mai is Norway's Constitution Day, and the celebration in Ballard is the largest of its kind outside of Oslo. Ballard has strong linkage to Scandinavian heritage with seminal ties to the fishing (maritime) and logging industries.

The procession started at 6 p.m. at 24th Avenue N.W. and N.W. 62nd Street and moved along Northwest Market Street and Ballard Avenue through Old Ballard to eventually end at Northwest Lone Place.

Spectators waving Norwegian flags sat along the streets and watched as Ballard High School and other high schools from the area, including Bellevue High School, showed off their marching bands.

The Ballard High School Viking Robotics team impressed spectators with their robot, which recently took first place at the FIRST Robotics world championship competition.

One onlooker reported feeling a long missed small-town feeling among the crowd.

"I don't know who to share this with but your name came to mind. I attended the parade last night for probably the 30th time. It was just amazing. So many bands, so many wonderful Norwegian costumes and very little candy throwing. I had a wonderful time. It again felt like the little town it used to be," said Peggy Storey.

Compared to last year there was one more group in the parade, which is a slight dip from the year before last, which saw 100.

## Sig Hansen arrested after altercation with Uber driver

"Deadliest Catch" star and Ballard native, Sigurd Hansen, was arrested during the early morning hours on May 18 after a dispute and altercation with an Uber driver.

The incident occurred when the Uber forced Hansen, his wife, daughter and son-in-law out of the car while en route to Hansen's home in Shoreline. The driver said that after picking up the group at the 2200 block of N.W. Market Street the ride was canceled in the cellphone app. The driver told them that they needed to re-order the ride; otherwise he could not go on. He stopped to let them out at the 5800 block of 20th Avenue N.W. The Police report states that the son-in-law offered \$100 cash to take the family the rest of the way home. The driver refused and told them that it's against Uber rules.

Police report that Hansen and his son-

in-law grew enraged and spat on the driver. Then Hansen allegedly got out and kicked the Uber vehicle, causing a dent. The driver drove a block down the street and called police.

Officers looked up the landing destination from the Uber app, which directed them to Hansen's house in Shoreline. Police say that once at the home they found Hansen and questioned him. They report that Hansen initially denied the incident and seemed very intoxicated. Officers moved to arrest Hansen in the doorway of his home, and they reported that Hansen briefly resisted before being handcuffed.

Police quote Hansen saying, "...an Uber guy, his name is [redacted], he took me home, we're here, we had Norwegian Independence Day, everybody's happy, I've

# South Park residents fight back against fear-inciting fliers

Brad Cerenzia works from his home in South Park, which makes it easy to keep an eye on the neighborhood.

It's not that he has an axe to grind. He simply wants to protect the community where he has lived for a number of years, a place and a population that he has grown to love.

When Cerenzia has a few minutes to take a break from his day job, he hops on his bike and cruises the streets.

He's on a mission to remove fliers that have been stapled to street posts that feature a number to call "for fast deportation of illegal immigrants."

And when Cerenzia tears down a sign, he replaces it with one of his own, reading "Welcome to South Park. Wherever you're from, we're glad you're our neighbor."

Cerenzia posts copies of the flier in Spanish and Vietnamese as well.

It all started three or four weeks ago, when Cerenzia learned about the first sign on Facebook.

A few neighbors banded together to discuss what to do.

"We decided as a group to tear it down," Cerenzia said. "We also wanted to counter this person's posts."

The neighbors all agreed that the language was antagonistic and designed to scare immigrants and refugees.

Lashanna Williams was part of the

group. "The sign is mean and makes people feel excluded and scared, like they don't belong," she said.

The neighbors then designed their own signs with a smiling Statue of Liberty.

Williams found printers to donate copies of the sign. In total, the group printed 1,400 fliers.

"We shared them with each other, people came by to pick the fliers up and we went to town," Cerenzia said.

The message was simple. "Wherever you're from, we're glad you're our neighbor," Cerenzia said. "I'm glad to stand up for my neighbors."

He doesn't blame area residents for being afraid to speak up—and he's happy to fight on their behalf.

"I know people who are terrified to leave their house," he said. "It really matters when you stand up for someone who doesn't have a voice, whether it's because they don't speak English or they're scared of their neighbors or because they've lived 40 years of terror in their country and just want to be left alone."

Williams is also often in the neighborhood hanging signs. She places her fliers next to the ones she finds offensive.

"We can coexist," she said. "It feels important to know that people like this are in our neighborhood. May it make the fabric of us even stronger."

He spends time cruising the area, tearing down signs he finds offensive and replacing them with a more positive message. His neighborhood has joined together in an effort to make everyone feel welcome.

Cerenzia hopes that taking action against bigotry is contagious.

His reception, however, hasn't been all positive. He says some people have told him that he is stifling the other sign-maker's free speech.

"You're welcome to say anything you

like—and you're also welcome to the consequences of that," Cerenzia said. "I want people to know that they don't have to—and they shouldn't—accept hateful behavior in this community. I would much rather have a spirit of hope in our neighborhood than allow this message of fear."

## At Frankie's, success began with a passion for food

Frank and Sue Genzale and cousin, Frank Yellam are celebrating their second year offering Italian recipes from "grandma's cookbook" after acquiring the former Filiberto's Restaurant in 2015.

Many Burien residents know the history of the Italian families who moved here decades ago. Mostly farmers, they were close and helped Pike Place Market become the Seattle icon it is today.

Frank and Sue started Frank's Quality Produce (1973) in that market, where they sell fresh produce every day. They are also partners with Duane's Garden Patch near Glen Acres on 8th Ave S.

Frank Yellam Jr., will tell you Frank G is the idea man. "I'm the guy behind the scenes," Yellam said. He opens each day while Frank G

is at Pike Place.

Selling produce is an early morning game. A game of one-upmanship between the booth of the first seller of veggies and fruit to the last booth and who has the best display, the best quality and trust that a buyer will come back the next week too.

Frank G and Sue applied this line of thinking to the restaurant. It is no secret that Italians' love of food and family can translate into a "dining experience." "It is more than the food," Yellam explains. It is a passion of dedication to fresh, quality ingredients and lots of hard work.

They all wait on tables, help at the bar and assist the staff. Even Yellam's mom, Babe, comes in each day to fold napkins.

The early generation of farmers (Frank G

got my family home, we're safe and sound, that's it! ... Nope! So, no is no! That means we're done."

Ballard holds the largest "Syttende Mai" —May 17th Norwegian Independence Day, outside of Oslo, Norway.

Once arrested Police state that Hansen told them that giving the driver cash didn't "jive" with the Uber paperwork and that now he had to "pay the piper." Police say that Hansen also said the driver was stupid for not taking the \$100 and that he would pay for the dent in the vehicle. "Of course I'll pay for it," Police report Hansen saying.

Officers reported that before taking Hansen into custody they removed a watch from his wrist that Hansen reported to be worth \$46,000.

The Uber driver positively identified Hansen, and he was taken to the North Precinct for processing and later booked in King County Jail for investigation of assault and property destruction with a bail set at \$2,000. He was later released Thursday.

Hansen's family declined to give statements about the incident.

Hansen apologized for the incident on Twitter: "Regarding the altercation last night, I am terribly sorry for my behavior and am very embarrassed by it. I owe a bunch of people apologies, first and foremost to our Uber driver, who was just trying to get us home safely. I hope I can make that apology in person. I have no excuse, and accept responsibility for my actions."

Hansen is known for being the captain of "Northwestern," on the Discovery Channel series "Deadliest Catch," which has aired since 2005.

### BURGLARY BREAKS IN FOR KEYS

Seattle Police are investigating a burglary that occurred at an apartment building located on N.W. 59th St. on May 13. Police responded after the manager of the building reported a break in. The suspect pried open a side door in order to gain entry to a community area of the building. Once inside the suspect broke into a lock box that contained the master building key. Expensive bikes in the common area were undisturbed. The manager is taking action to change the locks.

### LOVE AFFAIR LEADS TO ASSAULT AT BAR IN BALLARD

Police are investigating an assault that occurred inside a Ballard bar located on Ballard Avenue N.W. on May 14. The victim called police to N.W. 52nd St., and he told them that he was sucker-punched while inside a bar. His lip was swollen and teeth chipped. A female witness told police that the suspect was her ex-boyfriend and that they broke up in March. They were living with his parents at Kenwood Place North. He moved to Portland, but she was still living with his parents and looking for a new home. She was leaving the bar with the victim when the suspect punched him. She said that the suspect told her that he would punch her, too. Police are looking into surveillance footage of the scene.

### SUSPECT SOUGHT IN WHITE CENTER HOMICIDE

The King County Sheriff's Office is asking for the public's help finding a man involved in a homicide earlier this month. A Murder 1 warrant has been issued for Billy D. Williams, 30, of Oregon for the death of Seattle resident James Little, 30, on Sun., May 7. Little was attending a birthday party at a bar located in the 9800 block of 16th Avenue S.W. A group of women got into a fight, which moved outside. Little approached the group, and Williams pulled a gun and shot Little in the head, killing him. Detectives have not released a motive for the shooting. To provide information about Williams, call 911 or remain anonymous and call Crime Stoppers at 1.800.222.TIPS (8477).

### BAR ROOM ASSAULT ON S.W. ADMIRAL WAY

When police arrived at a bar located on the 4200 block of S.W. Admiral Way to investigate an assault at 9 p.m. on Sat., May 13, the Seattle Fire Department was already on the scene, checking on the victim. A witness said she was there with a group for a bachelorette party and only heard the assault, not seeing what happened. She also saw three women leaving the bar quickly afterwards. She thought the women were involved, because they had assaulted others in the past. The witness provided information about the suspects from her Facebook

page. The bartender also did not see the assault and did not access to surveillance cameras. Another witness saw the women get into a grey Toyota Corolla and speed away to the east. The victim did not remember the events leading up the assault. She said she woke up on the ground with people standing over her and blood running down her head. The fire department had already bandaged her injury, but she still had a lot of blood on her hands and face. She was transported to Harborview Medical Center. She told police that she did not know the three women and was not sure with what she had been hit.

### ASSAULT AT RESTAURANT ON S.W. ROXBURY

Around 2 p.m. on Fri., May 12, officers responded to a call about an assault in a restaurant located on the 1600 block of S.W. Roxbury Street. The victim said she had ordered her food, placed her plate on a table and went to get condiments from the other side of the room. She then saw another woman begin eating her food and asked her to stop. She told the woman that she would even buy her something. The victim tried to reach for her food and the suspect scratched her on the neck. A witness heard the commotion and tried to intervene, placing himself between the two women. The suspect tried to exit the establishment. The victim tried to stop her, and the suspect picked up a fire extinguisher and started swinging it wildly at her. The witness

then restrained the suspect until officers arrived. The suspect was placed under arrest, but the victim did not want to press charges. The victim made a statement and was given medical aid for scratch marks on her neck, as well as minor cuts and bruises on her shin and knuckles.

The staff at Daystar Retirement Village realized they had a unique situation on their hands, one they believed was worth celebrating.

The senior center, located at 2615 S.W. Barton St. in West Seattle, is home to five centenarians—Isabelle Mills, Ethel Taylor, Dorothea Huff and Dora Kinsch, each 101 years old, and Betty Novotny, who is 103.

Daystar hosted a special luncheon for the women on Thurs., May 18—and honored each with a signed letter from Washington Governor Jay Inslee.

“You have enriched many lives over the years, and your experiences are part of the very rich tapestry of our state and nation,” Inslee wrote. “Your recollections of a rich and full life are truly priceless treasures . . . I hope you realize the significance of the legacy you have been building over these many years.”

All five women gathered before the luncheon to share memories, after each visited the on-site beauty salon to prepare for the big day.

Novotny, who is originally from Chicago, worked as a treasurer for a small company. She has two children and eight grandchildren and enjoys oil painting, especially scenes of the mountains and portraits.

She said television was the biggest change in her lifetime. “It really opened the world to us,” she said.

And Novotny still enjoys watching the daily news broadcast. “I like to keep up with everything in the nation right now, whether it’s about problems or not,” she said.

Taylor and Mills are both originally from Minnesota—and Huff and Kinsch hail from Kansas.

Kinsch said she used to love to go bowling but now she prefers watching baseball games

and is a self-proclaimed Mariners fan. Her hobbies include crossword puzzles, reading, sewing and crocheting.

Taylor came to Seattle following her sisters’ footsteps. “My two younger siblings came here first, and they wrote to us to say Boeing was hiring,” she said. “We came here one-by-one.”

Taylor said arriving in Seattle and landing a job at Boeing was fortunate—and she is astounded at the way the city has grown over the years.

“The growth of Seattle has been huge,” she said. “When I came here, there weren’t even freeways.”

Mills grew up on a farm and became a teacher. She taught a number of grade levels in a one-room schoolhouse and has always loved to dance.

“I went dancing every week,” she said. Huff also grew up on a farm and became a teacher. “I had four children, which I think kept me wonderfully busy,” she said.

She said having a healthy lifestyle is the secret to a long life. “I ate very carefully,” she said. “And I don’t drink and don’t smoke.”

Mills said that dancing and playing music on the organ are what have kept her young.

Taylor walks every day and her advice for those who would like to reach 100 years old is simply, “Keep busy.”

Kinsch recommends having a little fun. “Eat what you want,” she said.

And Novotny’s secret to longevity came with a laugh. “Just keep breathing,” she said.

The women will be joined by two more centenarians at Daystar in 2018—June Blakney and Mary Mann.

The center hopes to make this an annual celebration—and in the future to invite other 100-year old Seattle residents to join them for lunch.

## Grunge icon, former West Seattle resident Chris Cornell, dead at 52; death ruled a suicide

The Associated Press reports that the medical examiner has determined Soundgarden singer Chris Cornell committed suicide by hanging in Detroit.

Chris Cornell, whose grunge rock icon status grew out of Seattle and West Seattle where he lived for years, apparently took his own life in a Detroit hotel room on May 18. He was 52 years old. He had been on tour with Soundgarden, the band that propelled him to fame and performed with the band Wednesday night in Detroit according to his representative Brian Bumbery in a statement to the Associated Press.

Police were called to the MGM Grand Hotel in Detroit at midnight in response to an emergency call from one of Cornell’s associates. Press reports claim that upon entry to the bathroom Cornell was found unresponsive and was pronounced dead at the scene.

Cornell formed Soundgarden in 1984 with Kim Thayil and Hiro Yamamoto and would go on to international fame that really began with the band’s third album Badmotorfinger. When Superunknown came out in 1994 the band hit the stratosphere selling five million albums. Cornell also worked with other Seattle rockers including West Seattle’s Eddie Vedder in the band Temple of the Dog which performed a triumphant sold out tour last fall including two dates at the Paramount in Seattle. Soundgarden

broke up in 1997 and Cornell went on to solo projects, and later rejoined Soundgarden in 2010. In 2001, he joined Audioslave, a supergroup that included former Rage Against the Machine members Tom Morello, Brad Wilk and Tim Commerford. That band broke up in 2007. Cornell and Soundgarden were again on tour this month.

Cornell was married to Sue Silver and lived on Gatewood Hill in West Seattle but the couple divorced in 2004. They had one daughter.

Cornell remarried Vicky Karayiannis, lived in Paris and had two children. The couple formed the Chris and Vicky Cornell Foundation in 2012 to protect vulnerable children living in poverty and abuse.

She met her partner only two days after moving to California—and when the post of executive director for Meredith Mathews opened up three years ago, the couple packed up and drove up the coast to Seattle.

Gonzales feels like she helped rebuild that location as a cornerstone of the community. She brings the same motivation to West Seattle.

"Our goal is clear—to do our part, with great love, to give each person in our community the opportunity to be healthy, secure, informed, connected, creative and compassionate," she said.

Rachael Steward, board member at the Meredith Mathews East Madison YMCA, said Gonzales left her mark on the location.

"She literally brought the branch back to life with her energy and vibrancy," Steward said. "She definitely made a difference."

Steward said Gonzales energized both the physical space and the staff.

Nicole Hill, senior director of education for the Meredith Mathews East Madison YMCA, recalls when Gonzales first started. "At the time I had no idea who she was," Hill said. "All I knew is that her reputation preceded her, in a good way."

Hill said Gonzales has a unique ability to build relationships with employees and community members alike. "She is extremely approachable and has a very light-hearted way about her," Hill said. "She has a talent for being able to rally people around a common vision or goal

in a way that feels really collaborative and empowering."

Hill also admires Gonzales' commitment to supporting diversity, inclusion, and equity efforts. "While we were sad to lose her at Meredith Mathews, I am excited that the West Seattle Y and surrounding community will be able to benefit from her leadership," Hill said.

Gonzales said her top priority now is learning more about the neighborhood and the nonprofits that serve it.

"There are so many organizations doing amazing work," she said. "If we don't talk to each other, we end up duplicating work."

Instead, she hopes to forge partnerships. "There are so many ways we can have a stronger, greater impact together," she said.

Gonzales is also reaching out to families, schools and community stakeholders to determine needs.

"We're focusing on developing programs that empower those who are most vulnerable in our community to have opportunities to succeed, grow and change their own lives," she said.

But she also wants to make the Y more fun—a gathering place for neighbors, where they can focus on health.

"This is my YMCA and I like to have fun," she said. "I want people to have fun in whatever they do. The Y is about the power of possibility, the power of community and the power of individuals coming together."

# Catastrophe hits Seattle

**M**ay is the month of lost cats in Seattle. When I check news on a neighborhood website or when I browse through local blogs, the top story often is about someone's quest for a missing Tom or Muffin or maybe Oscar. Telephone poles, too, are aflap with posters for missing tabbies—reward offered.

I know how the owners must feel. They're consumed by worry, out searching neighboring streets, calling pitifully for that favorite feline and worrying that, alas, something disastrous may have befallen Boots or Blackie. Not long ago, I discovered a neighbor traipsing through my backyard, calling for her beloved Rowdie. That hunt, unlike some, had a happy ending. After his weeklong absence, Rowdie was found hiding in a neighbor's garage, hungry but otherwise unharmed.

The task of searching for a missing indoor

cat—the kind most of us bird lovers prefer—is especially poignant. These are creatures who are not familiar with the multiple dangers of passing autos, predatory wildlife and other unpredictable hazards.

I am no stranger to the trauma of a missing indoor cat. Chloe, my late orange tabby—a female with extra toes and a rambunctious personality—managed to escape three times. One time she zoomed through my legs while I was answering the front door, another time when a house guest was careless and a third time when I was schlepping a load of groceries and didn't shut the garage door properly.

It's no wonder so many cats go astray in Seattle. The town is a proper cat city—more cats than dogs and more dogs than children. One third of our households have cats; one-fourth have dogs, and a mere 19 percent have children. It's not cat-besotted Seattle alone, but the entire Puget Sound region functions as the cat capital of the nation.

Given that Seattle has this outsized cat population, we are also on the hook at the supermarket, buying more cat food than any other U.S. city. And, although I haven't seen the industry statistics on kitty litter, those sales too are probably astronomical.

In keeping with our cat obsession, Mayor Ed Murray once a year renames City Hall, styling it as "Kitty Hall." That's the day when the Seattle Animal Shelter supervises a day-long cat adoption program, right there amidst municipal doings. City Hall visitors are encouraged to meet the Shelter's

tabbies, petting and cuddling before deciding on adoption. It's downright impossible to say no to a purring ball of fluff.

I learned early in my newspaper career to respect Seattle's cat obsession. My editor once warned me that, if I liked living here, I would never—no, not ever—advocate for a cat leash law. I was, however, allowed to write an occasional column about cats. And, in fact, one of my most popular city columns was the story about a cat named Amanda.

The way the story goes, this Seattle family had adopted a local stray, unaware of her testy disposition. They named her Amanda. The large feline immediately took up residence atop the family refrigerator and seldom budged. Whenever anyone got close, Amanda would snarl, reach out and swipe a lethal claw in their direction.

Since Amanda wasn't much of a companion, the family finally adopted a dog, an enthusiastic Labrador pup that they named Buddy. Buddy was only in the home for a few days when Amanda mysteriously disappeared. Although the family looked for the missing cat, they didn't persist. After all, Amanda was hardly a pet to inspire prolonged searches.

Skip ahead five years and the family's beloved Buddy streaked out into the street one day and was promptly hit by a car. He died soon after. A few days later, the family was still mourning Buddy when, to their surprise, they looked up. There was Amanda, back in her spot atop the refrigerator.

I had heard Amanda's story from a newspaper friend who knew the family and swore it was all true. The tale supplied

grist for one of the most popular newspaper columns I ever wrote, second in reader response only to the column I wrote about the origins of Frango chocolates. In Seattle, go figure: It's either cats or chocolates.

## A \$4,000 grant and Rotarians help local families in need

This is the story of Highline Public Schools Chief Operating Officer Scott Logan and the freezer that stopped working at the Des Moines Food Bank.

Logan, a member of the Rotary Club of Des Moines and Normandy Park, was volunteering at the food bank with fellow Rotarians when he heard the food bank freezer had stopped working. He knew that without adequate cold storage, the food bank would be hard pressed to store enough food for hungry families.

He found a solution through a grant program that matched the need with a donor. Thanks to a \$4,100 grant, a new commercial freezer was delivered this spring.

When other Rotary members heard about the freezer going down and the need for more freezer space, many responded. Enough additional funds were donated to purchase a second large freezer, expanding storage for perishable foods.

Barb Shimuzu, co-director of the food bank, explained that fewer people are eating—and donating—canned food. Because of this, the food bank needed new equipment and more space for storing donations of meat, dairy, and frozen food.

"Within two days of getting our two new freezers—boom—they were full to the gill!" she said.

What motivates Logan? "Part of my job is to try to match our needs with available resources, to support our amazing learners with equipment and facilities," he said. "This was just an extension of that mission for me, and coincided with volunteer work I believe in that benefits local students and families."

# Celebrating failure

In the long human history of great successes, inventions and innovations, lies an even longer trail of dismal flops, mistakes and failures.

In short: For every perfectly-operating tunnel-digging machine—there are also untold numbers of “Big Berthas.”

Many of my favorite quotes are about success and failure:

“If you set your goals high and they are a failure, you will fail above everyone else’s success.”

“Failure is disguised success.”

“The best lessons learned are from other people’s mistakes.”

Here’s another favorite: “Whenever you publish quotes from other people, don’t bother giving them attribution.” OK.

From the start, the human experience has been a series of trials and errors. Think of how many dirt clods and chunks of wood cavemen must have eaten before they figured out better cuisine.

“Hey, Oop! Come here! See if you don’t agree that this squirrel tastes better than boulders.”

Some poor ideas are immediately obvious. Gargling with hot sauce, skateboarding off the Space Needle, surfing behind a speeding car, or holding an open flame to a certain area of the body—are arguably poor concepts. No one knows exactly where such notions come from (except for the one with the open flame, which was invented at a college frat beer party by a guy named Stanley—whose name has been changed from Pat to protect his identity.)

But it’s when bad ideas wind up losing a lot of money that they become noteworthy. New Coke, the Betamax, Ben Gay brand aspirin, yogurt shampoo and the Edsel should all be in a museum of failure—if only there was one. Wait! There is one! Or soon will be.

The Museum of Failure is opening next month in Helsingborg, Sweden. Suitably, Helsingborg is the fourth largest city in Sweden, failing to crack the top three.

The Museum will house a curated collection of more than 60 products—products that the Museum website says, “provide insight into the risky business of innovation.” A guy named Dr. Samuel West—who is something called an ‘organizational psychologist’—is the person in charge. He says, “The purpose of the museum is to show that innovation requires failure.” With that kind of mission, if the museum turns out to be a flop—it will simultaneously be a success.

Among the goofed-up innovations the

museum will house:

- Bic pens specifically designed for women—presumably sleeker, prettier and less grubby than regular pens.
- Coca Cola Blak—a coffee-infused version of the soft drink. “Drink three and stay awake for a month.”
- A Harley-Davidson fragrance. No further details available, but it failed—probably because motorcycle riders don’t want anything masking the scents of sweat, fumes and bug juice.
- A battery-operated health and beauty mask. It looks like it was designed by the maniac from those Halloween movies. The mask stimulated facial beauty using small electrodes—in effect, shocking your face into looking more attractive. The claim was that—if properly used—you’d wind up looking like the actress Linda Evans. If improperly used—you’d wind up looking like the maniac from those Halloween movies.

The coming museum will also include some better-known near misses like the Segway. This sort-of scooter was introduced in the early 2000’s with more promise than a Trump-Comey wrestling match:

“The Segway will be as big a deal as the personal computer!”

“It will be more important than the internet!”

“Faster than a speeding bullet. More powerful than a locomotive.”

In fact, the Segway fell pretty well short of expectations—and that’s why it’s

featured in the soon-to-open museum. (Even though they are used occasionally by police to catch crooks—provided those crooks don’t exceed a speed of 12 miles an hour—and that they don’t try to escape via bike paths and sidewalks in Seattle where Segways are, of course, not permitted.)

Even relatively new products like the Google Glass will be featured in the new museum. If you remember, the Glass was designed to look like a pair of spectacles—that ideally nobody would notice were actually recording video. It turned out that silly things like privacy laws screwed up an otherwise fine idea—in much the way a virgin margarita screws up tequila.

In fact, some say, 80 to 90 percent of new products fail. That’s good news for the Museum of Failures. It should eventually be much larger than any other museum in the world. Unless there’s a Museum of Reality TV Shows.

Recently seen in a magazine cartoon: Two older men sitting in an office—as one of them remarks, “Those who don’t study history are doomed to repeat it. And those that DO study history are doomed to stand by helplessly while everyone else repeats it.”

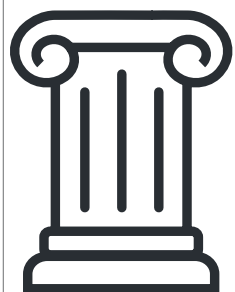

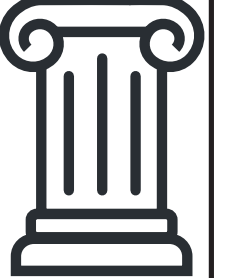

# Lowrise plan, high opposition



## PEGGY STURDIVANT At large in Ballard

Some of the people crowded into the west corner of Ballard Bauhaus looked like they didn't know what had hit them when it came to the small print of City of Seattle Land Use code. Others looked worn down by years of attempting to close loopholes dating back to 2010, but they were there too.

Magnolia resident, a UW Capital Project Planner and 25-year Architect David Moehring was delighted to have 30 people show up to discuss a land use application. A project with 19 new dwellings on a 17,800 square foot lot has touched a nerve.

Opposition to a project is often framed as single-family against multi-family. The neighbors who strained to hear Moehring, and one another, were a cross-section of Ballard Hub residents. There were townhouse residents, apartment dwellers, and yes, the increasingly rare single-family homeowner

in the Ballard Urban Village overlay.

"It's not about the density," one attendee said. "That ship has sailed. It's about not having any say about design or short plats until it's too late."

If this proposed development was on just any old corner it might not have become a magnet for so many on a Thursday night. The mostly "new blood" neighbors came to find out what they can do to modify the proposed new construction that includes the Baker St. House. At the northwest corner of N.W. 60th and 20th N.W. is a beautiful Victorian known as the Baker St. House. The house is on the City of Seattle's Historic Site list, built in 1888 and first purchased by saloonkeeper Henry Schmidt. The house is not slated for demolition; rather it will be relocated to north end of its lot so as to clear the way for three-lot combination of row houses and townhouses. Between 60th and 61st the entire west side of 20th N.W. is historically significant based on Ballard Historical Society's Department of Neighborhood grant study. There are also significant trees on at least two of the three properties.

The corner property was acquired by an entity doing business as Baker Street LLC in January. They have just acquired the two single-family homes west of the corner lot as of May 2017. Based on the combined lot size for the zoning (Lowrise One), the allowable number of new dwellings should be eleven. Using the subdivided lot method Baker Street LLC plans to construct 19 dwellings (for a total of 20 including the Victorian).

Nobody present spoke in support of a developer potentially subdividing in order to bypass the code that doesn't allow structures behind row houses, certainly not townhouses

that can be staggered to have structures in the front and back of a lot. As for how this land use action could be approved, Moehring admitted, "It's rarely challenged."

Alerted by a Ballard resident Moehring and his wife have volunteered their own time to contact local residents, conduct meetings and organize an appeal, "Simply driven by our background in architecture to keep Seattle a wonderful mix of homes and nature." They distributed information to nearby residents, in part because without explanation the Land Use Action: Notice to Subdivide will just seem like another fait accompli.

Instead it was packed at Bauhuas and whether a Google employee or a server able to buy their home in 1992 the attendees committed organize in order to explore options for downscaling the Baker Street LLC project. Eventually those who live within 300 feet of the project will be notified but as

with so much of the density under Streamlined Design Review, that ship will probably have sailed already.

From significant trees, to the simple fact that 19 new dwellings seems a bit much where there are now three, every concern was heartfelt. If it was going to be affordable housing it might be a different story but what others see clearly is that a developer is trying to maximize on a return that doesn't benefit anyone but them.
